

Notwithstanding the foregoing, Assignee will be responsible for paying any governmental fees for recording the assignment of the Patent Rights and will reimburse Assignor for its reasonable out-of-pocket expenses. Additionally, at the request of Assignee and in Assignor's sole discretion, Assignor will also assist in providing, and obtaining from the respective inventors, prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, powers of attorney, specifications, declarations or other papers and other assistance reasonably necessary for filing patent applications, complying with any duty of disclosure, and conducting prosecution, reexamination, reissue, interference or other priority proceedings, opposition proceedings, cancellation proceedings, public use proceedings, infringement or other court actions and the like with respect to the Patent Rights. 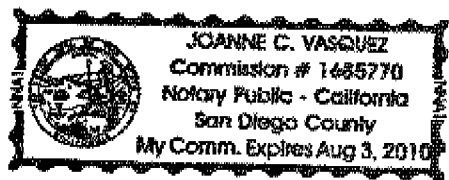
