ASSIGNMENT

WHEREAS, We, Peter Mathys, a citizen of Switzerland, residing at Neuhausen, Switzerland and Sarah Lanfranchi, a citizen of Switzerland, residing at Zürich, Switzerland have invented new and useful improvements in Apparatus for the Heat-Exchanging and Mixing Treatment of Fluid Media for which an application for United States Letters Patent was executed on even date herewith.

AND WE HEREBY authorize and request the Director of Patents and Trademarks to issue all such Letters Patent to the said Sulzer Chemtech AG in accordance with this instrument of Assignment.

AND WE FURTHER covenant and agree, in consideration of the premises, that we or our executors and administrators, will at any time upon request communicate to the said Sulzer Chemtech AG, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to us or to our executors and administrators, and that we will testify as to the same in any interference or other litigation when requested so to do by the said Sulzer Chemtech AG, it being understood that, Sulzer Chemtech AG will compensate us for our expenses reasonably incurred in complying with its requests.
