ASSIGNMENT

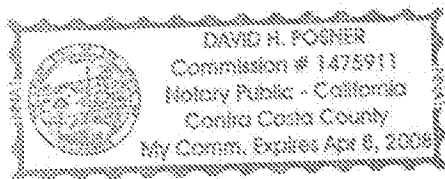
