AND INDIO DA COSTA DESIGN hereby agrees to communicate to INDIO DA COSTA ARQUITETURA or its representatives any facts known to us respecting said invention, to execute all divisional, continuation, reissue and foreign applications, sign all lawful

documents and make all rightful oaths relating to said invention, and to testify in any judicial or administrative proceeding and generally do everything possible to aid INDIO DA COSTA ARQUITETURA to obtain and enforce said Letters Patent in the United States or any foreign country when requested so to do by INDIO DA COSTA ARQUITETURA.
