## ASSIGNMENT OF PATENTS

THIS ASSIGNMENT OF PATENTS is made as of the September 21, 2007, by Joel L. Sereboff, an individual resident of the State of Maryland ("Assignor"), to Sereflex Group, LLC, a Maryland limited liability company with its principal place of business at 601 East Pratt Street, 3<sup>rd</sup> Floor, Baltimore, Maryland 21202 ("Assignee").

### BACKGROUND

Assignee and Assignor are parties to a Contribution Agreement dated as of September 21, 2007 (the "Agreement"), pursuant to which Assignor has agreed to contribute to Assignee and Assignee has agreed to accept from Assignor Assets and Intellectual Property (as defined in the Agreement), including without limitation the patents of Assignor.

In accordance therewith, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under Assignor's registered and unregistered domestic and foreign patents and patent applications, including without limitation, the patents and patent applications listed on Schedule A annexed hereto and incorporated herein by reference (all of the foregoing being referred to herein as the "Patents").

NOW, THEREFORE, Assignor, for and in exchange for the payment of the purchase price set forth in the Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Patents, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any of the Patents, whether arising prior to or subsequent to the date of this Assignment of Patents, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Patents not been made.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Patents shall be governed by and construed in accordance with the laws of the State of Maryland without giving effect to the principles of conflicts of laws thereof.

IN WITNESS WHEREOF, Assignor has caused its duly authorized officer to execute this Assignment of Patents as of the date first above written.


