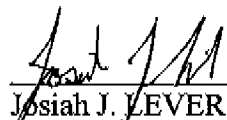
AGREEMENT

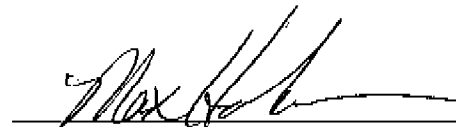
