## ASSIGNMENT

Assignor hereby promises and agrees, upon request, to execute all papers and all assignments necessary, expedient and permissible for the procurement of and to convey the entire right, title and interest in and to any Letters Patent in the United States and its territorial possessions, and in any and all jurisdictions, including any and all divisions, reissues, continuations, conversions, renewals or revivals thereof; and Assignor further promises and agrees to perform all rightful acts, and to execute all papers necessary, expedient and permissible in connection with any interference proceeding or legal action which may be declared concerning this Invention or any Letters Patent which may issue therefore in the United States and its territorial possessions, and in any and all jurisdictions, including any and all divisions, reissues, continuations, conversions, renewals or revivals thereof, for the purpose of proving the facts relating to the conception, development and completion of said Invention and to cooperate with the Assignee in every way possible in obtaining and producing evidence and proceeding with such interference proceeding or legal action.

Successors in Interest. This Assignment shall be binding upon and inure to the benefit of the respective heirs, successors, legal representatives and assigns of the Assignor and Assignee.
