ASSIGNMENT NUNC PRO TUNC

THIS ASSIGNMENT is made effective as of the 19th day of October, 2004, by Jens SCHOUENBORG, of Lund, Sweden (hereinafter referred to as the "ASSIGNOR"), who has invented certain new and useful improvements in the inventions which are the subject of the three (3) following U.S. and International Patent Applications (hereinafter referred to as the "PATENTS"):

International Application No. PCT/SE2005/001555, entitled "METHOD AND MEANS FOR ELECTRICAL STIMULATION OF CUTANEOUS SENSORY RECEPTORS," filed October 19, 2005.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the ASSIGNOR hereby assigns and transfers to NEUROVATION AB, a corporation of Sweden, of Mariagatan 8, S-223 53 Lund, Sweden, its principal place of business, and its successors, assigns and legal representatives (hereinafter referred to as the "ASSIGNEE"), all of the rights, title and interest of ASSIGNOR throughout the world in and to any and all inventions and improvements which are the subject of the PATENTS.

This Assignment includes all of ASSIGNOR's right, title and interest in, to and under the PATENTS and all divisions, renewals, continuations and continuations-in-part thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), and all applications for Letters Patent which may hereafter be filed for the PATENTS in any country or countries foreign to the United States, and all Letters Patent which may be granted for the PATENTS in any country or countries foreign to the United States hereby authorized, and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to record ASSIGNEE as the owner of all the PATENTS and to issue all Letters Patent for the PATENTS in the name of the ASSIGNEE, for the sole use of ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.

This Assignment includes the right to claim priority based on the filing dates of any or all of the PATENTS under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes. This Assignment also includes the right to sue for past infringement of the PATENTS.

ASSIGNOR hereby covenants and agrees with the ASSIGNEE, for itself and its heirs, legal representatives and assigns, to provide to the ASSIGNEE promptly upon their request and at their expense all pertinent facts and documents relating to the PATENTS and any legal equivalents as may be known and accessible to ASSIGNOR and to promptly execute and deliver to ASSIGNEE any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue or enforce patents based on any of the PATENTS, improvements on the inventions of the PATENTS or said equivalents thereof which may be necessary or desirable to carry out the purposes thereof.

ASSIGNOR hereby requests the Commissioner of Patents and Trademarks to issue any Letters Patent or Reissue Patent from the PATENTS, or extension thereof, to the ASSIGNEE.
