PATENT RELEASE OF SECURITY INTEREST

THIS PATENT RELEASE OF SECURITY INTEREST is made as of March 28, 2008, by Allied Capital Corporation, as Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and Norwesco, Inc. ("Company"), were parties to that certain Patent Security Agreement (United States) (Second Lien) dated as of September 2, 2005 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Company granted a security interest to Agent in, among other things, the Patents as security for certain obligations owing by Company to the financial institutions (collectively, the "Lenders") from time to time party to that certain Second Lien Credit Agreement by and among, inter alia, Company, Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Patents set forth on Schedule I hereto; and

WHEREAS, the Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on September 14, 2005, at Reel 016535, Frame 0952; and

WHEREAS, Company has requested that Agent release its security interest in the Patents and reassign the same to Company;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Company's right, title and interest in and to all of the following (the "Patent Collateral"):

(a) each Patent and application for Patent listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof; and


(b) all products and proceeds of the foregoing, including, without limitation, any claim by Company against third parties for past, present or future infringement of any Patent.
