ASSIGNMENT

WHEREAS, We,

Roslyn Yando, a citizen of the United States of America, residing at 5779 Rte 374 South, Brainardsville, NY 12915; and

Andrew Schonbek, a citizen of Canada, residing at 79 Woodcliff Drive, Plattsburgh, NY 12901; (**hereinafter INVENTORS**)

have invented certain new and useful improvements in a LIGHT FIXTURE for which we have executed an application for Letters Patent of the United States, Serial No. 29/302,527 filed January 18, 2008; and

WHEREAS, **Schonbek Worldwide Lighting Inc.** having offices at 61 Industrial Blvd., Plattsburgh, NY 12901, is desirous of obtaining the entire right, title and interest in, to and under the said improvements and the said application;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we the said **INVENTORS** have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
