LEARY III, a citizen of the United States of America, and Kesavannair PRAVEEN, a citizen of India, residing at 295 Greystone Terrace, Athens, Georgia 30606 US; 603 Southbound Dr., DeForest, WI 53532 US; 1020 Tybee Trace, Athens, Georgia 30606 US; 174 Talmadge Street, Apt.8, Athens, GA 30605 US and 1184 Pensacola Ct., Aurora, IL 60502 US, respectively, have invented new and useful improvements in **“NOVEL TELEOST DERIVED ANTIMICROBIAL POLYPEPTIDES”** for which we filed United States national stage patent application serial number 10/588,417 in the United States Patent and Trademark Office on August 4, 2006 and international patent application serial number PCT/US2005/005398 in the United States Patent and Trademark Office on February 18, 2005, said two applications claiming priority from two applications, **“TELEOST ANTIMICROBIAL AND CYTOTOXIC POLYPEPTIDES”**, United States provisional patent application serial number 60/545,370 filed on February 18, 2004, and **“MOLECULAR CHARACTERIZATION OF A NOVEL PATTERN RECOGNITION PROTEIN FROM NONSPECIFIC CYTOTOXIC CELLS: SEQUENCE ANALYSIS, PHYLOGENETIC COMPARISONS AND ANTIMICROBIAL ACTIVITY OF A RECOMBINANT HOMOLOGUE”**, United States provisional patent application serial number 60/623,909 filed on November 1, 2004. (Hereinafter these four applications are referred to as “the applications”).
