## PATENT ASSIGNMENT

WHEREAS, NCR CORPORATION, a corporation created under the laws of the State of Maryland (hereinafter ASSIGNOR), having an office at 101 West Schantz Avenue, Dayton, Ohio 45479, U.S.A., presently owns or controls certain patents and patent applications listed in the attached Appendix "A" (hereinafter TRANSFERRED PATENTS); and

WHEREAS, as part of the foregoing, ASSIGNOR desires to transfer, assign, convey, deliver and vest all of its interests and rights in TRANSFERRED PATENTS for all countries, jurisdictions and political entities of the world, to and in AT&T CORP., a corporation created under the laws of the State of New York, having an office at 32 Avenue of the Americas, New York, New York 10013, U.S.A. (hereinafter ASSIGNEE); and

WHEREAS, subsequent to this assignment, ASSIGNEE shall transfer, assign, convey, deliver and vest all of its interests and rights in TRANSFERRED PATENTS for all countries, jurisdictions and political entities of the world, to and in LUCENT TECHNOLOGIES INC., a corporation created under the laws of the State of Delaware.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, effective March 29, 1996, ASSIGNOR by these presents does, subject to existing rights and licenses of third parties, hereby assign, convey, transfer and deliver, and agrees to assign, convey, transfer and deliver to ASSIGNEE, its successors, assigns and legal representatives or nominees, ASSIGNOR's entire right, title and interest, for all countries, jurisdictions and political entities of the world, along with the right to sue for past infringement, to all TRANSFERRED PATENTS with respect to which, and to the extent to which, ASSIGNOR now has or hereafter acquires the right to so assign, convey, transfer and deliver.

ASSIGNOR agrees that, upon request it will, at any time without charge to ASSIGNEE but at ASSIGNEE's expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for vesting title to TRANSFERRED PATENTS in ASSIGNEE, its successors, assigns and legal representatives or nominees; including but not limited to any acts which may be necessary, desirable or convenient for claiming said rights and for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in ASSIGNEE, its successors, assigns and legal representatives or nominees.




