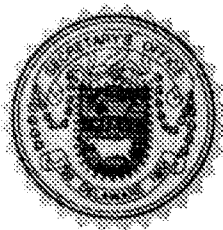

**THIRD:** The name of the limited liability company into which the Corporation shall be converted as set forth in the Certificate of Formation is "Praxsys Biosystems, LLC".



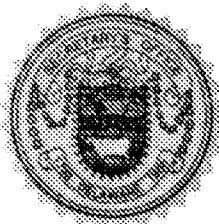
