(2) in and to said United States patent application, in and to all other patent applications (including divisional, continuation, continuation-in-part, §111(b) provisional, §111(a), reissue applications, and international patent applications designating the United States) based upon said invention, and in and to the patent or patents to be granted thereon, including reissues thereof, if any, to the full end of the term or terms for which said patent or patents may be granted; and

(3) in and to all patent applications on said invention now or hereafter filed in countries foreign to the United States of America, including patent applications filed under
