AND, we, the said ASSIGNORS, do hereby authorize and request the Commissioner of Patents to issue the said Letters Patent of the United States to said ASSIGNEE as the assignee of the whole right, title, and interest in and to

the same, for the sole use and behoof of said ASSIGNEE, its successors and assigns.

AND, we, the said ASSIGNORS, hereby authorize and empower said ASSIGNEE, its successors, assigns, and nominees to invoke and claim for any application for Letters Patent for any improvements or invention filed by said ASSIGNEE, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may hereafter be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from us.

AND, we, the said ASSIGNORS, hereby consent that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document which may be required in any country for any purpose and more particularly is proof of the right of ASSIGNEE or its nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may hereafter be substituted for it.

AND, we, the said ASSIGNORS, for the considerations aforesaid, do hereby covenant and agree to and with the said ASSIGNEE, its successors and assigns, that we, our executors and administrators shall and will do all lawful acts and things, and make, execute, and deliver any and all papers, affidavits, assignments, and other documents, in the United States and all foreign countries, which, in the opinion of counsel for said ASSIGNEE, its successors and assigns, may be required or necessary more effectively to secure to and vest in said ASSIGNEE, its successors, or

assigns, the whole right, title, and interest, in the United States and all foreign countries, in and to said improvements and invention, application, Letters Patent, rights, titles, benefits, privileges, and advantages hereby

sold, assigned, transferred, and conveyed or intended so to be.
