Pursuant to Section 264(c) of the Delaware General Corporation Law and Section 18-209(c) of the Delaware Limited Liability Company Act, Zinio Merger Sub, LLC, a limited liability company organized and existing under the law of the State of Delaware (the "*Company*"), hereby certifies the following information relating to the merger of Zinio Systems, Inc., a corporation organized and existing under the law of the State of Delaware ("*Zinio*"), with and into the Company (the "*Merger*"):

FIRST: The name and state of incorporation of each constituent entity that is a party to the Merger is as follows:

FOURTH: The certificate of formation of the Company shall be the certificate of formation of the Surviving Company.

FIFTH: The executed Merger Agreement is on file at the executive offices of the Company at 139 Townsend Street, Suite 300, San Francisco, California 94107.

SIXTH: A copy of the Merger Agreement will be furnished by the Company, on request and without cost, to any member of the Company, any stockholder of Zinio, or any member of the Surviving Company.

SEVENTH: This Certificate of Merger shall be effective upon filing.
