ASSIGNMENT

THIS ASSIGNMENT, effective the 25th day of January, 2008, is made and entered into by and between Large Scale Biology Corporation, a Delaware corporation, with offices at 3333 Vaca Valley Parkway, Suite 900, Vacaville, California 95688 ("LSBC"), Large Scale Proteomics Corporation, a Delaware Corporation with offices at 3333 Vaca Valley Parkway, Suite 900, Vacaville, California 95688 ("LSPC") and Agilent Technologies, Inc., a Delaware Corporation, with offices at 5301 Stevens Creek Boulevard, Santa Clara, CA 95051 ("Agilent"). LSBC, LSPC and Agilent are sometimes referred to herein collectively as the "Parties" and individually as a "Party."

WHEREAS, LSBC and Agilent have entered into an Asset Purchase Agreement pursuant to which LSBC has sold certain assets, including those patent applications listed in Schedule A ;

WHEREAS the PCT application Serial No. PCT/US02/00060 of Schedule A was owned by LSPC at the time of application but the PCT application and JP national application 2002-556705 mistakenly also named the inventors as applicants;

WHEREAS LSPC may be still showing as the owner of record of some of the patent applications of Schedule A in different Patent offices, and LSBC and LSPC own all the right, title, and interest to those patent applications and the inventions therein, and wish to ensure that all their right, title, and interest is transferred to Agilent such that Agilent can be recorded in the respective Patent Offices as the sole owner of all those patent applications.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Parties hereby agree as follows:


1. Assignment. LSBC and LSPC hereby sell, assign and transfer, all of their right, title and interest in and to each of the patent applications listed in attached Schedule A, the inventions disclosed therein and any patents issuing therefrom, including any continuations, continuation-in-part, divisional, reissue, reexamination, or similar applications thereon which may be filed thereon in any country, and their right to file foreign applications thereon and claim priority under the provisions of any international treaty or convention..

3. Governing Law. This Assignment shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of California without regard to the conflicts of laws principles thereof.


5. Binding. This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective heirs, successors and assigns.
