ASSIGNMENT

WHEREAS, I, RAINER MARTINI, a citizen of Germany, residing at 613 Hudson Street, Hoboken, New Jersey 07030 (hereinafter "Assignor") have invented a new and original INFRARED WAVELENGTH CONVERTER FOR IMAGING APPLICATIONS BASED ON QUANTUM WELL DEVICES, filed May 17, 2007 as U.S. Application Serial No. 11/667,986, which is a §371 of International (PCT) Application No. PCT/US2005/042443 filed November 22, 2005, and which claims benefit from U.S. Provisional Serial No. 60/630,004 filed November 22, 2004.
