for which invention an application for patent was executed and for which U.S. Patent 7,048,015 issued on May 23, 2006 (hereinafter referred to as Patent Property); and





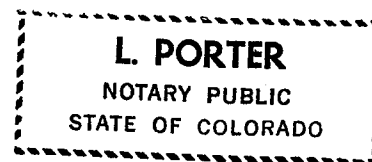
