(to be renamed Clear With Computers, LLC)**

Pursuant to the provisions of Sections 3.051 to 3.056 and Section 101.356(d) of the Texas Business Organizations Code (the "*TBOC*"), Orion IP, LLC, a Texas limited liability company (the "*Company*"), hereby adopts the following Certificate of Amendment to the Certificate of Formation of the Company.

**Article 1 - Entity Information**

The name of the filing entity is Orion IP, LLC. The filing entity is a limited liability company. The file number issued to the filing entity by the secretary of state is 800634474 and the date of formation of the entity is March 30, 2006.

**Article 2 - Amendment**

The amendment changes the Certificate of Formation to change the name of the filing entity. The second sentence of Article 1 of the Certificate of Formation of the Company is hereby amended to read in its entirety as follows:
