I hereby request that said Letters Patent be issued in accordance with this Assignment.

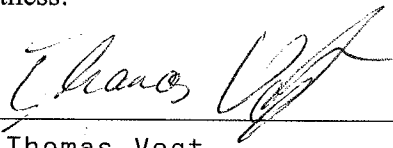

invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns, and other legal representatives.

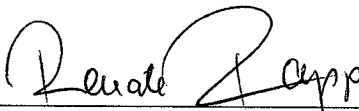
