ASSIGNMENT

WHEREAS, **Massachusetts Institute of Technology**, a Massachusetts corporation having a place of business at 77 Massachusetts Avenue, Cambridge, Massachusetts 02139 (and hereinafter called the Assignor, which term shall include its successors and assigns), owning rights to application for Letters Patent of the United States, Serial No. 11/557,779, filed November 8, 2006 (hereinafter called the Application), desires to assign and transfer an undivided interest in and to said Application and in and to any Letters Patent that may be granted thereof in the United States and its territorial possessions;

NOW, THEREFORE, to all whom it may concern be it known that for and in consideration of said agreement and of other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor has sold, assigned and transferred and by these presents does hereby sell, assign and transfer unto said Assignee, its successors, assigns, and legal representatives, an undivided interest in and throughout the United States of America, its territories and all foreign countries, in and to the inventions described in said Application, together with an undivided interest in and to said Application and such Letters Patent as may issue thereon or claim priority under international convention, including but not limited to continuations, divisionals, reissues, and reexaminations of said application or such Letters Patent; said undivided interest to be held and enjoyed by said Assignee for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which said Letters Patent may be granted; Assignor hereby conveys an undivided interest in all of Assignor's rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of industrial property by filing any such applications for Letters Patent.


