If the right applicable to any such patent application allows an assignee to be the applicant of the patent application, Robert Bosch GmbH shall have the right to be identified as applicant of the patent application and the right to claim priority of said United States application. This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of

Assignee. All other rights to said invention, said applications and said patents, U.S. or foreign, including the right under any of said patents to manufacture, use, sell or offer for sale the invention covered by said patents, or to license or permit use of said invention, remain with Assignee and shall be assignable by Assignee without the consent of Robert Bosch GmbH.
