I do hereby authorize and request my attorneys, Trexler, Bushnell, Giangiorgi, Blackstone & Marr, Ltd., of 105 West Adams Street, Chicago, Illinois 60603, to insert here in parentheses (Serial No. 11/913,648, filed Nov. 5, 2007) the date and serial number of said application when officially known.
