## RELEASE OF SECURITY INTEREST

(the "Borrower") assigned certain interests in assets of Borrower, including the assets described on Exhibit A to that certain Strict Foreclosure Agreement (the "Foreclosure Agreement"), dated as of February 14, 2008, by and between Agent and Borrower (the "Collateral") to Agent under that certain Pledge and Security Agreement, dated as of September 5, 2006, that certain Pledge and Security Agreement (10% Senior Secured Notes under Securities Purchase Agreement), and that certain Pledge and Security Agreement (12% Senior Secured Notes under Securities Purchase Agreement), including the patents recorded with the U.S. Patent and Trademark Office on September 6, 2006 at Reel 018224 Frame 0196.


WHEREAS, pursuant to the Foreclosure Agreement, Borrower has agreed to transfer to Agent ownership of the Collateral.
