## RELEASE OF PATENTS

THIS RELEASE OF PATENTS is made as of May 5, 2008, by AirWorks Funding LLLP, Sands Brother Venture Capital LLC, Sands Brothers Venture Capital II LLC, Sands Brothers Venture Capital III LLC, Sands Brothers Venture Capital IV LLC, Critical Capital Growth Fund, L.P., and Hilltop (as assignee and successor of interest to all of RS Properties I LLC rights under the Patent and Security Agreement), as lenders (collectively "Lenders"). The capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in that certain Patent Security Agreement dated as of June 19, 2007 (the "Patent Security Agreement") by and between the Lenders, Kronos Advanced Technologies, Inc. WHEREAS, Pledgors have disposed of all of their ownership rights and interests in the Patents; and

WHEREAS, Pledgors have requested that Lenders release its liens on the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lenders hereby release any and all claims, liens, security interests and other encumbrances to the Patents arising under the Patent Security Agreement.
