BETWEEN

- (1) **ACCENTUS PLC** (Reg. No. 04146523) whose registered office is at 3rd Floor, 11 Strand, London WC2 5HR, United Kingdom (the "Seller")
- (2) **ERG (AIR POLLUTION CONTROL) LIMITED** (Reg. No. 01389099) whose registered office is at 42, London Road, Horsham, West Sussex RH12 1AY, United Kingdom (the "Buyer") - From 13 March 2008, Enviro Centre Enterprise House, Foundry Lane, Horsham, West Sussex, RH13 5QG.

IT IS AGREED as follows:

1. Pursuant to the Agreement between the Seller and Buyer dated 19th February 2008 relating to the assignment of the V-TEX Technology, the Seller hereby assigns to the Buyer all its right, title and interest in and to patent number US4943007 ("Spray Generators", *Bowe et al*, date of patent: July 24 1990) (the "Patent"), together with all goodwill and statutory and common law rights attaching to the Patent including the benefit of all priority dates, the right to seek and obtain registrations in other countries and the right to sue for damages and other remedies for infringement or misuse of the Patent which may have occurred prior to the date of this Assignment and to retain those damages.
2. The Seller shall, at the Buyer's cost and request, sign all documents and do all things which may be required by law or which the Buyer may reasonably request from time to time (including executing as soon as reasonably practicable after the date of this Assignment all documents which the Buyer may reasonably require to effect the registration or recordal of the assignment of the Patent to the Buyer in any relevant jurisdiction) by way of further assurance of the rights assigned under this Assignment.
3. This Assignment and the relationship between the parties shall be governed by, and interpreted in accordance with, English law and the parties agree that the courts of New York are to have non-exclusive jurisdiction to settle any disputes arising out of or in connection with it.
