UNITED STATES PATENT ASSIGNMENT

WHEREAS, BH Transition Limited (formerly known as BrandHandling Limited), a corporation organized under the laws of the United Kingdom, having a principal place of business at Eighth Floor, 6 New Street Square, London, EC4 3AQ and company registration number 05617725, is the sole and exclusive owner of an undivided one-half right, title and interest in and to the United States Design Patent Application Serial No. 29/302,353, filed January 15, 2008 entitled "ARTICLE OF FOOTWEAR" (the "Patent Application"); and

Common Market Convention, or any other Convention or Union for each country of said Convention or Union; and all rights of priority resulting from the filing of the Patent Application, the same to be held and enjoyed by BrandHandling International Limited, its successors and assigns, for its own use and enjoyment, to the end of the term or terms of such patent as may be granted on the Patent Application or on any other application claiming any right of priority to the Patent Application, as fully and entirely as the same would have been held and enjoyed by BH Transition Limited if this assignment and sale had not been made; together with and including without limitation any and all claims for damages by reason of past infringement of any such patent, with the right to sue for and collect the same for the sole and exclusive use and enjoyment of BrandHandling International Limited, its successors and assigns.

AND, FURTHER, BH Transition Limited does hereby authorize and request any official whose duty it is to issue patents to issue any and all patents on the Inventions or resulting from the Patent Application, or any divisions, continuations, continuations-in-part, or re-issues thereof to BrandHandling International Limited, as assignee of its entire interest, and hereby covenants that it has full right to convey its entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
