ASSIGNMENT OF PATENT APPLICATION

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, I-Kang Yu of Palo Alto, California, David Q. Chow of San Jose, California, Charles C. Lee of Cupertino, California, Abraham Chih-Kang Ma of Fremont, California, and Ming-Shiang Shen of Hsin Chuang, Taipei Hsien, Taiwan/Republic of China, have invented certain new and useful improvements as set forth in the specification of the application for the United States patent, which was filed on Feb. 21, 2008, and assigned Serial No. 12/035,398, that has been executed by the undersigned prior hereto or concurrently herewith on the dates indicated and is entitled:

“High Endurance Non-Volatile Memory Devices”

- 5) warrant and represent that any assignment, grant, mortgage, license, contract, or other agreements that conflicts with this assignment has not been entered, and will not be entered by the undersigned.
