DOES HEREBY CERTIFY:

FIRST: That the Corporation was originally incorporated pursuant to the General Corporation Law on December 9, 1996 under the name of Argonaut Risk Cores, Inc.

SECOND: That the Corporation filed an Amendment to its Certificate of Incorporation on February 17, 1999, amending its Certificate of Incorporation and changing its name to ARC Cores, Inc.

THIRD: Article FIRST of the Certificate of Incorporation, as amended, is hereby amended and restated in its entirety to read as follows:
