
ASSIGNMENT

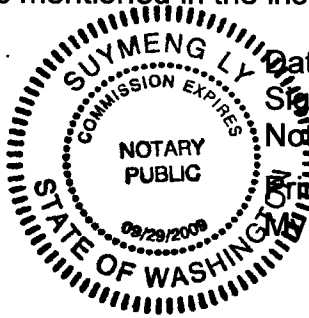


