ASSIGNMENT**(Joint)**

WHEREAS, Michael S. McGRATH, residing at 1452 Benito Avenue, Burlingame, CA 94010 and **Kenneth G. HADLOCK**, residing at 345 Santiago Street, San Francisco, CA 94116; (each referred to as "Assignor") have made an invention(s) (the "Invention(s)") set forth in applications for patent of the United States, entitled **METHODS FOR TREATING VIRAL INFECTIONS USING POLYAMINE ANALOGS**, and which is

- (1) a provisional application
 - (a) to be filed herewith; or
 - (b) bearing Application No. 60/719,573, and filed on September 23, 2005 and

- (2) a non-provisional application
 - (a) to be filed herewith; or
 - (b) bearing Application No. 11/535,001, and filed on September 25, 2006.

- (a) the Invention(s);

- (b) the applications for patent identified in paragraph (1) and (2);

- (c) the right to file applications for patent of the United States or other countries on the Invention(s), including all rights under the Paris Convention for the Protection of Industrial Property and under the Patent Cooperation Treaty;

(d) any application(s) for patent of the United States or other countries claiming the Invention(s);

(e) any application(s) for patent of the United States or other countries claiming priority to the applications for patent identified in paragraph (1) and (2) or any application(s) for patent claiming the Invention(s), including any division(s), continuation(s), and continuation(s)-in-part; and

(f) any provisional or other right to recover damages, including royalties, for prior infringements of any application for patent identified in the preceding paragraphs (b)-(e); and

(g) any patent(s) of the United States or other countries that may be granted for or on any application for patent identified in the preceding paragraphs (b) – (e), including any reissue(s) and extension(s) of said patent(s).

The above-granted rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had this sale and assignment not been made.

The Assignor hereby represents to the Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, or if applicable, at such time said prior agreement was executed, the Assignor is a lawful owner of an undivided interest in the entire right, title, and interest in and to the Invention(s), that the Invention(s) are unencumbered, except, if applicable, by obligation to assign in accordance with said prior agreement, and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner set forth herein.

The Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that the Assignor will sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done in connection with any and all proceedings for the procurement, maintenance, enforcement and defense of the Invention(s), said applications, and said patents, including interference proceedings, without charge to the Assignee, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns.

The Assignor hereby requests the Commissioner of Patents to issue said patents of the United States to the Assignee for the sole use and behalf of the Assignee, its successors, legal representatives, and assigns.


