## **ASSIGNMENT**

WHEREAS, WE, CHRISTOPHER M. REINSEL, a citizen of the United States residing at 1748 Mill Pond Court, Neenah, Wisconsin 54956; MICHAEL R. AND ASSIGNORS HEREBY authorize and request the Commissioner for Patents or any other proper officer or agency of any country whose duty it is to issue patents on applications as described above, to issue all said Letters Patent to GPCP, as assignee;

AND ASSIGNORS HEREBY warrant and covenant that we have full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict with this Assignment;

AND ASSIGNORS HEREBY agree to communicate to GPCP or its representatives any facts known to us respecting said invention and/or Application, to execute all divisional, continuation, continuation-in-part, reexamination, reissue

and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention and/or Application, and to testify in any judicial or administrative proceeding and generally do everything possible to aid GPCP to secure full and complete protection for the invention and/or Application or that may be necessary to vest in GPCP the complete title to the invention and/or Application hereby conveyed and to enable it to record said title and enforce said Letters Patent in the United States or any foreign country when requested so to do by GPCP.

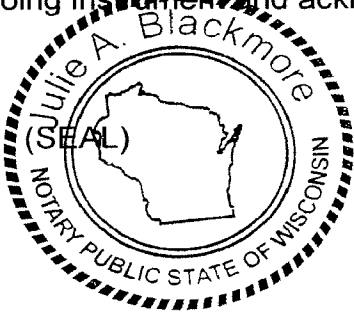
