We hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said Letters Patent, when granted to said Group Dekko, Inc., as the assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of said Group Dekko, Inc., its successors and assigns.
