
ASSIGNMENT



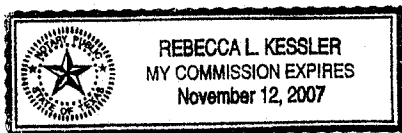


