**Ms CRISTINA MARÍA-ÁNGELES MÉNDEZ MARROQUÍN**, who is unmarried and of full legal age, with address at Avda. Lomas del Rey, 1-3, San Sebastián de los Reyes (Madrid, Spain), the holder of National Identity Card (DNI) No. 07504196-D.



In my opinion, they have the necessary legal capacity to enter into this deed of **ADDITION TO A DEED OF DISTRIBUTION OF AN INHERITANCE**, for which purpose they set out as follows:

**WHEREAS**

1) By means of a deed executed before me, the undersigned Notary, on 22<sup>nd</sup> November 2007 under protocol number 2,859, the inheritance on the death of **Mr ENRIQUE**

**MÉNDEZ CORMAN**, husband and father respectively of the appearing parties, who died in Madrid on 23<sup>rd</sup> July 2007, was divided.

He died while married in first and only nuptials to **Ms MARÍA PILAR MARROQUÍN PÉREZ**, leaving two surviving daughters of the marriage, who are called **Ms CRISTINA MARÍA-ÁNGELES** and **Ms DIANA PILAR MÉNDEZ MARROQUÍN**.

**II. INHERITANCE DOCUMENT:** Mr ENRIQUE MÉNDEZ CORMAN died leaving an open will which he had granted in Alcobendas (Madrid) before the Notary Public Mr Fulgencio A. Sosa Galván on 28<sup>th</sup> December 1999 under protocol number 3,525 in which, after making a number of declarations, he provided that:

“... **ONE:** He leaves his wife Ms María Pilar Marroquín Pérez the full ownership of the fully disposable portion of his estate (*tercio de libre disposición*), with the option mentioned below.

**TWO:** He names his daughters Cristina María de los Angeles and Diana Pilar Méndez Marroquín his sole and universal heirs in equal shares, with a right of substitution in favour of their descendants and without prejudice to the legal beneficial share (*cuota legal usufructuaria*) belonging to his wife.

**THREE:** The testator instructs that, when the inheritance is distributed, his wife María Pilar Marroquín Pérez be given the full enjoyment of his estate for the rest of her life (*usufructo universal vitalicio*), if she so prefers, by way of payment for the fully disposable portion of his estate left to her.

**FOUR:** In the event that any of his sons or heirs object to the provision made by the testator in the preceding clause (Clause Three), he leaves his above mentioned wife the full ownership of the fully disposable portion of his estate and expressly acknowledges her entitlement to the legal beneficiary share to which she is entitled by law; in which case the child or heir who opposed will inherit the third of his estate to which he or she is entitled by law (“*legítima estricta*” or “*legítima corta*”).

**FIVE:** He revokes his prior wills”.


