







## ASSIGNMENT

### BETWEEN

(1) WU, Zhiqiang, a citizen of the People's Republic of China of NO. 3, HUANGLIANGONGYEDADAO, LELIU, SHUNDE, FOSHAN CITY, GUANGDONG, 528323, PEOPLE'S REPUBLIC OF CHINA; ZENG, Shaofana, citizen of the People's Republic of China of NO. 3, HUANGLIANGONGYEDADAO, LELIU, SHUNDE, FOSHAN CITY, GUANGDONG, 528323, PEOPLE'S REPUBLIC OF CHINA and ZHONG, Xiangyong, a citizen of the People's Republic of China of NO. 3, HUANGLIANGONGYEDADAO, LELIU, SHUNDE, FOSHAN CITY, GUANGDONG, 528323, PEOPLE'S REPUBLIC OF CHINA ("The Assignor")

and

(2) GUANGDONG FUWA ENGINEERING MANUFACTURING CO.,LTD., a limited liability company incorporated under the laws of the People's Republic of China of NO. 3, HUANGLIANGONGYEDADAO, LELIU, SHUNDE, FOSHAN CITY, GUANGDONG, 528323, PEOPLE'S REPUBLIC OF CHINA ("The Assignee")

### WHEREAS

- (A) The Assignor created a design for a nut for semi-trailer leg ("the Design"). Representations of the Design are annexed hereto in Attachment A.
- (B) The Assignor has agreed to assign all rights in the Design to the Assignee on the terms set out herein and to execute this Assignment.

1. 2. This Assignment shall be governed by and construed in accordance with the laws of the People's Republic of China and the parties hereby submit to the non-exclusive jurisdiction of the courts of the People's Republic of China.
