Assignor hereby irrevocably sells, conveys, assigns and transfers to Assignee and its successors and assigns forever, without any restrictions, limitations or reservations all of Assignor's right, title and interest in and to the Patents, including without limitation, (i) any and all rights of priority and any foreign patents issuing thereon, (ii) all extensions, divisions, reissues, renewals and continuations thereof, (iii) all income, royalties or payments now or hereafter due or payable with respect to the Patents, (iv) all past, present and future claims, counterclaims, credits, causes of action, choses in action, rights of recovery and rights of setoff against third persons for infringement or other unauthorized violation of the Patents, together with the right at law or in equity to sue for and collect any resulting recovery of damages, lost profits, legal fees and costs, including from acts which may have occurred prior to the Effective Date, and (v) any and all rights corresponding thereto throughout the world (all collectively, the "Assigned Rights"), and Assignee does hereby accept assignment of the Assigned Rights from Assignor.

Assignee, its successors and assigns shall hold the rights to the Assigned Rights as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor shall provide to Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's reasonable request and expense (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required): (i) in the preparation and prosecution of any application for the Patents, (ii) in the prosecution or defense of any interference, infringement or other proceedings that may arise in connection with any of the Assigned Rights, including, without limitation, testifying as to any facts relating to the Assigned Rights assigned herein and this Assignment, (iii) in obtaining any additional protection for the Assigned Rights that Assignee reasonably may deem appropriate, and (iv) in the implementation or perfection of this Assignment.





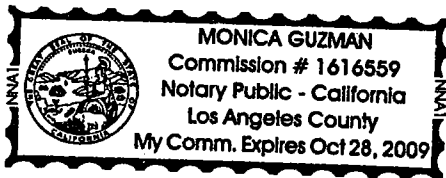
