ASSIGNMENT

WHEREAS We, CHOI, Hae ock of 605-401, Songnimmaeul Apt., Hagi-dong, Yuseong-gu, Daejeon, Republic of Korea; CHOI, Hyun-Kyun of 202-401, Drium Apt., Daejeong-dong, Yuseong-gu, Daejeon, Republic of Korea; OH, Hyun-Seo of #17, Jeongnim-dong, Seo-gu, Daejeon, Republic of Korea; and CHOI, Wan Sik of 104-304, Chonggu Narae Apt., Jeonmin-dong, Yuseong-gu, Daejeon, Republic of Korea (hereinafter referred to as "ASSIGNORS"); have invented certain new and useful improvements in:

**METHOD FOR PROVIDING VEHICLE ACCIDENT INFORMATION AND  
APPARATUS THEREFOR**

execute all papers necessary in connection with the United States and foreign applications when called upon to do so by the said ASSIGNEE, its successors or assigns, and that We will, at the cost and expense of the said ASSIGNEE fully assist and cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.
