**ASSIGNMENT**

**WHEREAS, I, LARRY QUINN**, now deceased, late of Santa Ana, California, survived by my wife, Janice Ann Quinn, now deceased, represented by Richard S. Hubbell, Jr., Executor of the Estate of Janice Ann Quinn, having a residence address at 136 Topaz, Newport Beach, California 92662-1025, have co-invented certain new and useful improvements and have undivided joint ownership interests disclosed in U.S. Patent Numbers 6,705,049 issued March 16, 2004, 7,258,785 issued August 21, 2007, and in U.S. Patent Application Number 10/819,445, filed April 6, 2004, entitled RAIN AND STORM WATER FILTRATION SYSTEMS, and 11/181,594, filed July 14, 2005 (issued November 27, 2007 as U.S. Patent Number 7,300,590), entitled METHOD AND APPARATUS FOR SEPARATING OIL AND DEBRIS FROM WATER RUN-OFF, executed by me on even date herewith;

**AND WHEREAS STEVE E. ESMOND AND ROBERT K. WEIR**, individuals, residing at 17 Evensen, Irvine, California 92602-2403 and 2390 Forest Street, Denver Colorado 80207-3261 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEES") want to acquire the entire right, title and interest in and to said improvements and applications.

**NOW, THEREFORE**, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I have sold, assigned, transferred and set over, and do hereby sell, assign, transfer and set over to ASSIGNEES the entire right, title and interest in and to said improvements, and said applications and all divisions and continuations thereof, and all United States Letters Patents which may be granted thereon and all reissues, reexaminations and extensions thereof, including the right to sue or otherwise bring action and to collect and receive damages therefrom, for past infringement thereof, and all priority rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries, and all patents (including all continuations, divisions, extensions, renewals, substitutes, and reissues thereof) granted for said improvements in any foreign countries; and I hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to ASSIGNEES in accordance with the terms of this Assignment;

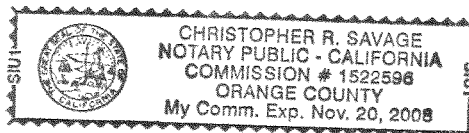
