PATENT ASSIGNMENT

WHEREAS, WE, Scott R. Fisher, a citizen of the United States, residing at 8965 Heather Ann Drive, West Chester, County of Butler, and State of Ohio 45069; Matthew K. Caskey, a citizen of the United States, residing at 1727 Clark Drive, Loveland, County of Clermont, and State of Ohio 45140; John P. Crutcher, a citizen of the United States, residing at 2679 Newtown Road, Cincinnati, County of Hamilton, and State of Ohio 45244; Robin S. Glassburn, a citizen of the United States, residing at 4609 Hallandale Drive, Batavia, County of Clermont, and State of Ohio 45103; and, Wendell H. Morris, a citizen of the United States, residing at 11161 Woodlands Way, Cincinnati, County of Hamilton, and State of Ohio 45241 (hereinafter referred to as "ASSIGNORS"), have invented an ELECTRONIC LOCK BOX WITH MECHANISM IMMOBILIZER FEATURES, for which we have executed an application for Letters Patent of the United States, of even date herewith, and

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors, and assigns, to the full ends of the respective terms for which said patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by us, had no sale and assignment of said interest been made.

ASSIGNORS HEREBY authorize and request the Director of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


