IS BETWEEN

- (1) GEOLA TECHNOLOGIES LIMITED of Sussex Innovation Centre, Science Park Square, Falmer, East Sussex, BN1 9SB, UK ("Geola");

RECITALS

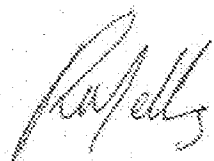
