

ASSIGNMENT

WHEREAS I, Tomohiro YAMAZAKI (hereinafter referred to as "ASSIGNOR") of Kyoto, Japan have invented certain new and useful improvements in: **OPTICAL SPACE TRANSMISSION DEVICE INCLUDING ROTATABLE MEMBER** which claims priority to Japanese Application No. 2007-029181, filed February 8, 2007 and for which I am about to file or have filed an application for Letters Patent of the United States;
