
PATENT ASSIGNMENT

For good and valuable consideration, receipt of which is hereby acknowledged, we, Gregory J. Foster, 5231 W. Berteau Ave., Chicago, Illinois 60641, United States of America, Ron Llanes, 4717 Lacey Ave., Lisle, Illinois 60532, United States of America, and Robert Sheldon, 955 Willow Rd., Winnetka, Illinois 60093, United States of America, hereby sell and assign to Columbia Insurance Company ("Assignee"), a corporation organized and existing under the laws of the State of Nebraska, having its principal place of business at 3024 Harney Street, Omaha, Nebraska 68131, U.S.A., its successors, assigns, nominees, or other legal representatives, the entire right, title, and interest in and to the invention entitled "Knife Sheath" invented by us, and the application for United States patent therefor, which has not yet been assigned a Serial Number, and all original and reissued patents granted therefor, and all divisions and continuations thereof, including the subject matter of any and all claims which may be obtained in every such patent, and the right to apply for and obtain patents, registered designs and Utility Model Registrations which may be granted thereon in any foreign countries. We further covenant and agree that we will, at any time upon request, do everything legally possible to aid the Assignee, its successors, assignees, nominees, or other legal representatives, either in its or their own names, to apply for, obtain, and enforce proper patent, registered design and/or Utility Model protection for said invention in all countries, all without further consideration but at the expense of the Assignee, its successors, assigns, nominees, or other legal representatives.

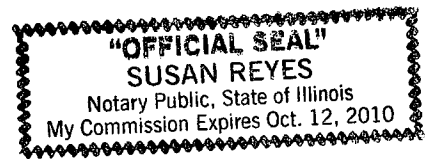
