ASSIGNMENT OF PATENT

This Assignment is entered into by and between **TRUST ESTABLISHED UNDER ARTICLE 4th OF THE WILL OF FRANK GREGORY**, deceased (the "Trust"), the **ESTATE OF FRANK GREGORY**, deceased ("Estate"), and **BETTY GREGORY ("Betty")**, all having an address at 67 Summit Avenue, Waldwick, New Jersey 07463 (hereafter collectively referred to as "Assignor") and **WARREN GEORGE, INC.**, a New Jersey corporation having an address of P.O. Box 413, Foot of Jersey Avenue, Jersey City, New Jersey 07303, (hereafter referred to as "Assignee").

WHEREAS, Assignor is the sole and exclusive owner of United States Letters Patent 6,732,818, issued May 11, 2004 (the "Patent");

WHEREAS, Assignor wishes to transfer, convey and assign to Assignee all of its rights in the Patent; and

WHEREAS, the parties wish to formally memorialize the terms of said assignment.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

1. Consideration. In exchange for the payment of One Dollar (\$1.00), the receipt and sufficiency of which is hereby acknowledged, and in accordance with the prior agreement of the parties, as set forth in the Stock Purchase and Debt Repayment Agreement dated, December 22, 2006 and the Prepayment and Purchase Agreement dated May 12, 2008, Assignor does hereby convey, transfer and assign and deliver unto Assignee, its successors and assigns forever, all the right, title, interest and claims of Assignor in, to and relating to the Patent, and any and all right to sue for any and all past and future infringements of the Patent, the same to be held and enjoyed by Assignee and its successors and assigns to their own use, to the full end of the term for which the Patent is granted, as fully and entirely as the same would have been held by Assignor if this Assignment had not been made.

2. Assignor's Cooperation. Assignor hereby agrees to execute and deliver to Assignee, at the request of Assignee, any and all additional documents which Assignee deems necessary or desirable for the transfer, by complete assignment, of all Assignor's right, title and interest in and to the Patent, and to assist it in securing protection thereon in the United States.






