CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment ("Assignment") shall be effective as of July 18, 2001 ("Effective Date") by and between:

EMILIO SACRISTAN ROCK, residing at 1ra Cerrada de Flor Silvestre No. 3 Int. 6, Col. San Andres Totoltepec, Dec. Tlalapan, CP 14400, Mexico D.F., MEXICO; ("ASSIGNOR"), and

INNOVAMEDICA S.A. de C.V., having a principal place of business at Cantil 175, 4 Col. Jardines del Pedregal, Mexico D.F., CP 01900, MEXICO ("INNOVAMEDICA").

1.0 Background

1.1 ASSIGNOR, through his employment with INNOVAMEDICA, as either employee or contractor, as the case may be, invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States titled "IMPEDANCE SPECTROSCOPY SYSTEM AND CATHETER FOR ISCHEMIC MUCOSAL DAMAGE MONITORING IN HOLLOW VISCOUS ORGANS" U.S. Non-Provisional Patent Application Serial No. 09/907,781, filed on 07/18/2001, U.S. Patent No. 6,882,879, issued on 04/19/2005, which claims priority to U.S. Provisional Patent Application 60/219,281 filed on 07/19/2000, invention titled: "IMPEDANCE SPECTROSCOPY SYSTEM AND CATHETER FOR ISCHEMIC MUCOSAL DAMAGE MONITORING IN HOLLOW VISCOUS ORGANS." The subject matter of his patent application shall be referred to as the "Invention."

1.2 INNOVAMEDICA, as employer of ASSIGNOR, owns all right, title and interest in and to the Invention. ASSIGNOR, as consideration for his employment with INNOVAMEDICA, agreed to execute all the necessary documents in order to perfect and confirm INNOVAMEDICA's ownership in any inventions created or developed by ASSIGNOR during his employment with INNOVAMEDICA.

1.3 For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR is executing this Assignment in order to confirm INNOVAMEDICA's ownership in and to formally transfer to INNOVAMEDICA all right, title and interest in and to the Invention and all Letters Patent which may be granted from the Invention in the United States or any foreign country.

2.0 Assignment

2.1 ASSIGNOR sells, assigns and transfers to INNOVAMEDICA, effective as of the Effective Date first set forth above, the full and exclusive right, title and interest in and to the Invention and all Letters Patent which may be granted from the Invention in the United States, including any continuation, division, renewal, substitute or reissue thereof for the full term or terms for which the patents may be granted.

2.2 ASSIGNOR also assigns all of his right, title and interest in and to the Invention in all foreign countries, including the right to apply for a patent in any foreign country and the right to all current and further applications for patents for the Invention, including the right to claim International Convention priority.

2.3 ASSIGNOR further transfers and assigns to INNOVAMEDICA all causes of action, rights, and remedies arising under any such patent or application prior to or after the Effective Date of this Agreement.


