ASSIGNMENT

WHEREAS, we, Scott E. Jahns, Hudson, Wisconsin; Russell Robert Paul, Brooklyn Park, Minnesota; and Shiva Prakash Moosai, New Hope, Minnesota, have invented certain new and useful improvements in **IMPLANTABLE MALLEABLE PENILE PROSTHETIC DEVICE**, for which an application for Letters Patent of the United States has been made, and which may be identified in the United States Patent Office by Application No. 11/923,171, Filed October 24, 2007.

We further authorize said Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name if desired, in any and all foreign countries, and additionally to claim the filing date of said United States application and/or otherwise take advantage of the provisions of the International Convention.

Upon said consideration we do hereby covenant and agree with the said Assignee, its successors and assigns, that we will not execute in writing or do any act whatsoever conflicting with these presents, and that we or our executors or administrators will at any time upon request, without further or additional consideration, but at the expense of the said Assignee, its successors and assigns, execute such additional writings and do such additional acts as said Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, reissued or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in enforcing any rights occurring as a result of


such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

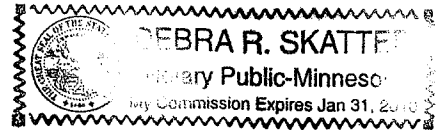
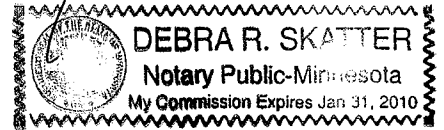
