PATENT ASSIGNMENT

WHEREAS, Telefonaktiebolaget L M Ericsson (publ) a Swedish public company with reg. no. 556015-0680, and having a place of business at Torshamnsgatan 23, 164 83 Stockholm, Sweden, (hereinafter called "Assignor") is the owner of all right, title, and interest in and to United States Patent Numbers listed in Appendix A (hereinafter collectively referred to as "PATENT RIGHTS");

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, the said ASSIGNOR has Sold, Assigned, and Transferred effective as of an Assignment Date of March 31, 2008, and does hereby Sell, Assign, and Transfer to the ASSIGNEE, ASSIGNOR'S entire right, title, and interest in and to said PATENT RIGHTS as of March 31, 2008 (subject to licenses granted to ASSIGNEE and ASSIGNEE's AFFILIATES, or to any third parties under agreements of ASSIGNEE or ASSIGNEE'S AFFILIATES that were effective up to and including March 31, 2008), the same to be held and enjoyed by the ASSIGNEE for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives; together with all claims for damages by reason of past infringement of said PATENT RIGHTS, with the right to sue for and collect the same for its own use and benefit and for the use and benefit of its successors, assigns, or other legal representatives; together with all claims for damages by reason of past infringement of said PATENT RIGHTS, with the right to sue for and collect the same for its own use and benefit and for the use and benefit of its successors, assigns, or other legal representatives and further in accordance with the Patent Assignment and License Agreement executed on March 31, 2008;

ASSIGNOR hereby covenants that it has the full right to convey its interest in said PATENT RIGHTS herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith;

ASSIGNOR further agrees to execute and deliver, from time to time, all further instruments of conveyance, assignment, and further assurances and perform all such other acts as may reasonably be required to transfer and assign all of the ASSIGNOR'S right, title, and interest in and to and under said PATENT RIGHTS to the ASSIGNEE. *jm*
