ASSIGNMENT

We, Frieder Loesel, residing at Bassermannstr. 38, 68165 Mannheim, Germany; and Josef F. Bille, residing at Hermann Loens Weg, 44/1, 69118 Heidelberg, Germany; have invented a method and apparatus entitled SYSTEM AND METHOD FOR ALTERING INTERNAL STRESS DISTRIBUTIONS TO RESHAPE A MATERIAL, hereinafter called the "invention."



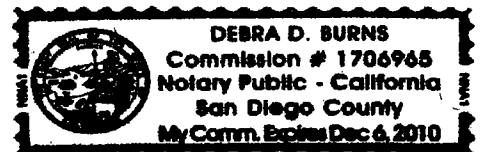
