

and ASSIGNOR hereby covenant that ASSIGNOR have the full right to convey the entire interest herein assigned, and that ASSIGNORS have not, and will not execute, any agreement in conflict herewith;

AND ASSIGNOR HEREBY further covenant and agree that ASSIGNOR will communicate to ASSIGNEE any facts known to ASSIGNOR respecting said invention and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said invention in all countries.
